A. Budget Update/Safety Information/Bond and Seismic

Budget – The overall year to date general fund spending has increased from last year at this time.

Safety – There were no recordable incidents in the month of January.

Bond and Seismic: Current Bond Revenue is \$8,231,650. Jr. High expenditures to date equaled \$7,724,265 and Foster and Holley combined totaled \$3,389,721.

- B. Facilities Project Report- Josh Darwood gave a report on work done this month at the Jr. High and projects that are completed at Foster and Holley.
- C. Facility Project Grant: Roadmap of the Long Range Facility plan. Mr. Strong went through all the plans and due dates are that we will be doing and hoping to be done by March. The district will be asking for parent, staff, and community member volunteers to participate in a high school facilities committee, a Kindergarten to 8th grade facilities committee, or an athletic facilities/fields committee.
- D. 2020-2021 School Calendar. A committee provided this recommendation to the Superintendent and he did not modify their recommendations. Rachel Stucky discussed the committee recommendations. This is a first read for the board. March is the official month to approve the calendar. The committee looked at other school districts to make sure we are sharing the same vacation days. Trying to work with a specific trainer to come to our school district for a professional development day so that date will change.
- E. Student Investment Account Update. Rachel Stucky and Superintendent Yahraes provided the board with an update regarding the survey committee's work and our next steps in the SIA process. SIA committee met to review all survey input/comments and reviewed next steps. The hope is to get the application to the board next month. The deadline is in April.
