They were not only the highest in the 4A level, but the whole state. Their team GPA was 3.83. Fed 50 families with the Thanksgiving baskets. Leadership class went on a trip and there were 15 new people added to the honor club.

Consensus to use OSBA for the Strategic Plan was given from all board members. What services would they provide - helped with 3 of the 4 last strategic plans the district plans. It would cost \$5,000 to \$8,000 dollar charge depending on how much we would use them.

3. Jason Hay from the Linn Benton ESD provided information on services that ESD provides to the district. Thank Superintendent Martin for his input and support. Jason shared ADMw over the years, 22-23 Quick Stats, Services Data and Grants. LBL ESD services districts, schools and students by providing equitable, flexible and effective educational services through economy of scale. Their vision is to be a responsive and transparent organization that supports districts by embracing continuous improvement in helping every child succeed

6. Information/Discussion

A. Budget Update/Upcoming PERES Pension Cost Increases: Kevin Strong gave a budget report on year to date general fund spending compared to adopted budget & year to date spending last year by object.

Upcoming PERS Pension Cost Increase- Many school districts have established PERS side accounts to reduce their share of the statewide unfunded pension liability. In the 2002-03 fiscal year, Sweet Home issued pension obligation bonds and then forwarded the proceeds to the Oregon Treasury where the funds were placed in a side account. The funds were invested and cost savings were achieved when investment returns exceeded the debt payments. Side account balances are now being depleted and our rate relief will diminish significantly in the upcoming biennium. During the 2025-2027 biennium, we anticipate paying approximately \$2.2 million more to PErS than in the current biennium. By comparison, Portland, Salem-Keizer, and Beaverton anticipate increases of \$30 million, \$20 Million, and \$19 million, respectively. Many smaller districts, when evaluated as a percentage of payroll, will face even greater impact. We have been anticipating a PERS rate increase and we have built reserves to help cushion the hit. However, the financial impact will still be felt as we work to develop next year's budget.

B. OSBA Election Information- Chairman Redick explained the OBSA election and shared what they are voting on.
