Observation: VIOLATION OF SECTION 3-306.14 *PRIORITY* Unwrapped or potentially hazardous food is reserved, specifically: CARTONS OF MILK AND WHOLE APPLES THAT ARE NOT EATEN ARE PLACED ON A SHARING TABLE. THESE ITEMS ARE PUT AWAY AT THE END OF THE LUNCH PERIOD. MILK PUT AWAY AT TIME OF INSPECTION AT 45F. KIDS OBSERVED HANDLING THE ITEMS AND NOT WASHING HANDS FIRST.

Corrective Action: REQUIRED CORRECTION: CORRECT IMMEDIATELY. After being served or sold and in the possession of a consumer, unwrapped or potentially hazardous food that is unused or returned by consumer may not be reused. Non-potentially hazardous food that is still packaged and in sound condition may be reserved. MILKS, AND ANY OTHER POTENTIALLY HAZARDOUS FOOD, CAN NOT BE PLACED ON THE SHARING TABLE. APPLES ARE EATEN WITH THE SKIN ON, THEREFORE, THEY CAN NOT BE RESERVED. DISCUSSED WITH STAFF AT TIME OF INSPECTION.
